#### UNIVERSAL TESTING

On June 8, 2020, Dr. Rachel Levine, Pennsylvania's Secretary of Health, issued an order for required testing of residents and staff in Skilled Nursing facilities. In response to this directive, baseline testing of residents and employees at Loyalhanna Care Center was completed on June 30th and July 1st. The specimens were collected by our

administrative clinical staff and sent off to the Pennsylvania Bureau of Laboratories in Exton, PA for testing. Since then, we are pleased to report that were able to maintain our COVID-free status! Even though we have worked through eliminating the virus and now have evidenced-based testing to support the success of our efforts to maintain that status, we remain vigilant in the processes that have been put in place. We continue to monitor our residents for signs and symptoms of illness, including fever, cough, and other respiratory symptoms. Our staff also continues to undergo screenings and symptom monitoring before and after each shift in order to identify and remove potential threats of illness before they can spread to our residents. Should anyone become symptomatic, we will follow the next steps in our testing plan, which has been developed under the guidance of the Department of Health and other federal and state agencies.

Unfortunately, this threat remains very real, especially since there is still no available cure or vaccination to combat it. The future of testing, screening, visitation, and the general operation of nursing facilities remains to be seen; however, we strive to meet and exceed the expectations set forth by the agencies directing the fight against this pandemic.
